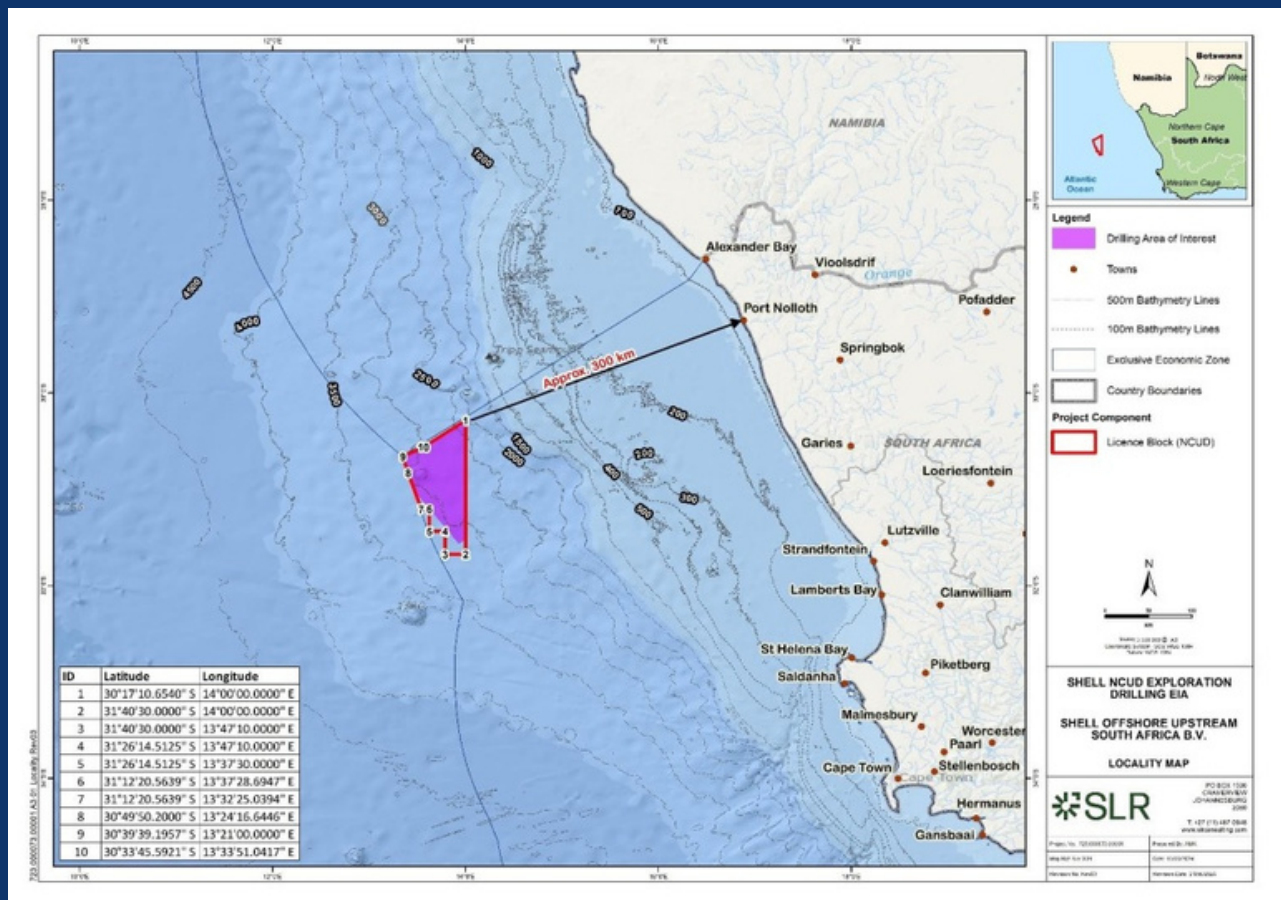

Indawo ekuthethwa ngayo iqala kwi-300km ngaphandle kolwandle ukusuka ePort Nolloth, yehla ecaleni kolwandle ukuya eStrandfontein. Le ndawo ingaphezulu kwe-5,254km², kwaye amanzi aphakathi kokuya kwi-2,500m ukuya kwi-3,200m ubunzulu.

UMphathiswa wezeMbiwa nePetroleum (DMR) uye wamkela isicelo seShell sokumba eNCUD. Oku kuthetha ukuba urhulumente unikile imvume yokuba iShell kunye namaqabane ayo baqale umsebenzi wokugrumba phakathi ko-2026 no-2027.

Ingxelo ye-ESIA (Environmental and Social Impact Assessment) ibonisa ukuba kuza kugrumba imingxunya emibini yokuqala ngonyaka wokuqala, nezinye ezintathu ngonyaka wesibini.



AMANYATHELO OKUFUMANA IMVUME

Step **1** **Ilungelo lokuPhanda (ER):** Lifunyanwa emva kokuba imvume yokusingqongileyo inikiwe.

Step **2** **Ingxelo ye-ESIA:** Ingxelo ebhaliweyo malunga nefuthe leprojekthi kwindalo noluntu, yenziwa yi-SLR Consulting.

Step **3** **Izimvo zoluntu:** Bonke abantu abachaphazelekayo banikwa ithuba lokunika izimvo zabo.

NgoDisemba 2024, i-EAP yapapasha ingxelo yokuqala ye-ESIA ukwazisa uluntu nabanye abanomdla malunga nezinto eziye zafunyanwa, kuquka: lingozi ezibangelwa yiprojekthi; Amathuba anokuthi avuleke ngenxa yalo msebenzi limpembelelo ezinokubakho kwindalo nakuluntu lindlela zokunciphisa ezo mpembelelo.

Step **4** **Imvume ye-EA:** DMR igqiba ngokusekelwe kwiingcebiso ze-PASA ukuba iyayinika okanye iyala imvume.



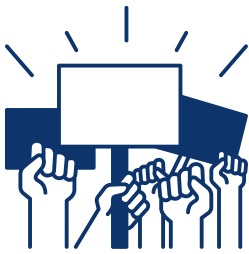
IVUNYIWE:

IZIPHUMO KWIINDALO ZASELWANDLE

- Ingxolo engezantsi kolwandle inefuthe kwiintlanzi: inokubangela ukuba zihambe okanye zingabi nakuziva.
- Ingxolo inokonakalisa amalungu aphulaphayo eentlanzi, okanye ithintele unxibelelwano lwezixhobo zabo zokuzikhusela.
- Izinambuzane zaselwandle eziphakathi kwendawo yokugrumba ziquka iintlobo ezisengozini: iilethabheki, iiblu whales, iLoggerhead turtles, njl.
- Ukuphuphuma kweoyile kunokutshabalalisa indalo, kubangele ukufa kwezilwanyana, okanye kube nefuthe elide elibi kuqoqosho nokutya koluntu.



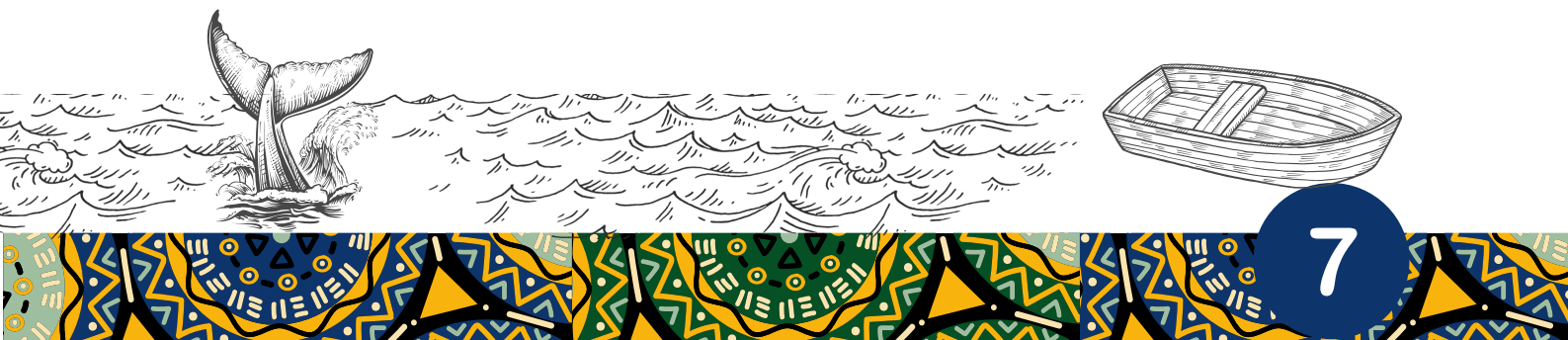
IZIPHUMO KUBOMI BOMNTU

Abalobi abancinci (Small-Scale Fishers) baxhomekeke elwandle.
Ukuphazamiseka:

- Kungabangela ukuba amahotele, iindawo zokutyela, kunye norhwebo oluxhomekeke kutyelelo lutshabalale.
- Iindleko zokuhamba kweekhephu zinganyuka ngenxa yokuhanjiswa ngaphandle kweendawo zokuloba.
- Ukuba ioyile iphumela elwandle, iindawo zokuloba zingavalwa ixesha elide, kungabikho msebenzi, kwaye ilahleko yemali ibe phezulu.

IZIPHUMO KWIINKQUBO ZENKCUBEKO NELIFA

- Ulwandle luthathwa njengento ephilayo phakathi kweentsapho nezizukulwana zabantu bomthonyama.
- Iimpembelelo ziluvo oluncwile: ziphazamisa unxibelelwano namanina noosiyazi.
- Amanzi angcolileyo aphazamisa imisebenzi yempilo neyesintu.
- Ukugrumba kunokuphazamisa umhlaba othethwa njengendawo yokuphumla kwemiphefumlo yabaphantsi.
